

Ministerial Travel and Entertainment Expenses

To carry out their duties, Ministers are often required to undertake both intrastate and interstate travel. Ministers are also expected to host events, including for visiting dignitaries and representatives from a variety of not-for-profit and other government and non-government organisations. Each Minister is provided with entertainment allowances under the *Parliamentary Salaries, Superannuation and Allowances Act 2012*.

The expenditure below includes Ministers' travel and entertainment expenses for the six-month period **1 October 2023 to 31 March 2024**. Expenditure reflects when the expenses have been paid or reimbursed and may not line up with actual travel / entertainment dates.
